SUBJECT: MEASURE M PUBLIC INFORMATION EFFORT

ISSUE

Since the Board of Directors voted to place Measure M on the November ballot, the Communications team has been implementing a comprehensive public information effort across the county to educate the public about the ballot measure. Because the Board and Board staff have a vested interest in this effort, this is a status update on the progress that is being made.

DISCUSSION

From late June through early November, Metro staff will have attended 300 community presentations, events and festivals to educate the public about Measure M. Many of the presentations are being done by CEO Phillip Washington and other members of the Senior Leadership Team. The bulk of the meetings are being covered by the Community and Municipal Affairs Division within Community Relations.

Also, Community Relations staff has also attended city council and councils of government meetings and are tracking the cities and organizations taking a position on Measure M. To date, 19 cities with a cumulative population of 4.75 million have taken a support position, and 19 cities totaling a population of 936,000 have taken an oppose position. Others are expected to take a position in the next few weeks.

In addition to community presentations and having a presence at events and festivals, the public information process has also included a variety of tactics including bus, rail and shelter ads; billboards; print advertising; Metro Briefs radio ads; news blogs and articles; press events showcasing Metro's progress, informational materials; web updates; social media campaigns; and educational videos.

The Marketing Division has created numerous informational materials which have been provided to a wide variety of organizations to make available to their constituents. In addition, the Social Media Team has utilized targeted digital media tactics to encourage various sectors of the public to learn more about the various elements of Measure M.

The Community Relations staff developed and hosted the first Metro Older Adults Expo on October 4 in the Union Station Ticket Room. Materials on Measure M were made available to the 300 attendees.

The Public Relations Division has planned and hosted 50 press events from June through November to promote the progress Metro is making across the county. The team has also fielded numerous media inquiries on Measure M and has proactively scheduled the CEO and the Chair for high-profile print, radio and television media interviews.

The Government Relations Division has held numerous Measure M briefings with state and federal officials and their staff. They've briefed all 36 Congressional offices and the offices of the two U.S. Senators as well as all 78 offices of the State Legislative Delegation, the Governor's office and key committee staff, including two legislative briefings during this period. Metro's representatives in Sacramento and Washington are maintaining regular contact with our Congressional and State Legislative Offices.

Customer Relations and Customer Programs and Services staff are handing out Measure M materials when they assist customers and while staffing community events. Materials are also being handed out to customers who are utilizing our Pilot Mobile Customer Center as an easy, convenient way to purchase reduced fare products.

Community Relations and Public Relations worked together to conduct Metro staff briefings on Measure M at Gateway and the various operating divisions, including a videotaped presentation that is available on Metro's Intranet. The video is also playing on the television screens in the divisions so that operations and maintenance staff can view the presentation at their leisure.

NEXT STEPS

Communications staff will continue to educate the public through the various tactics outlined above. From now through early November, staff will coordinate and attend 80 community meetings, events and festivals. Metro will also host two Telephone Town Hall meetings led by Board Chair Fasana, Mayor Garcetti and the CEO to educate many county residents at one time and answer their questions about Measure M. The tele town halls are scheduled for October 12 and 19 at 6:30 p.m.
