**SUBJECT: INVESTMENT TRANSACTIONS FOR THE MONTH ENDED**  
**FEBRUARY 28, 2017**

**ISSUE**

The attached investment transactions reports are provided in accordance with our Investment Policy approved January 26, 2017, and the California Government Code.

**DISCUSSION**

During the month, investment purchases totaled \$337.8 million and investment sales totaled \$21.0 million, including interest. In addition, during the month of February, a call option was exercised in the portfolio. Following is a summary of transactions made by the respective Portfolio Managers (amounts in thousands).

Our short and intermediate investment portfolios, valued at market plus accrued income, totaled \$1.00 billion as of February 28, 2017 versus \$1.01 billion as of January 31, 2017. The decrease was due to current month expenditures in excess of funding and revenues. After accounting for withdrawals, the month end yield of the Operating Portfolio was 1.35% versus the benchmark of 1.35%.
