

**SUBJECT: INVESTMENT TRANSACTIONS DURING THE MONTH ENDED  
JULY 31, 2008**

**ISSUE**

The attached investment transactions reports are provided in accordance with our Investment Policy approved January 24, 2008, and the California Government Code.

**DISCUSSION**

During the month, investment purchases totaled \$1.016 billion, and investment sales totaled \$17.8 million, including interest. In addition, no call options were exercised in the portfolio. Our short and intermediate investment portfolios, valued at market plus accrued income, totaled \$1.727 billion as of July 31, 2008 versus \$1.724 billion as of June 30, 2008.
