FY 09 CALL FOR PROJECTS AGREEMENTS AND CALL FOR

PROJECTS WITH JUNE 30, 2009 LAPSE DATE

ISSUE

The Board adopted a Timely Use of Funds Policy and a Lapsing Policy for the Call for Projects. The Timely Use of Funds Policy requires that sponsors whose projects have first year of funding in FY 08-09 have a fully executed Memorandum of Understanding (MOU)/Letter of Agreement (LOA) no later than December 31, 2008. We also require that a project that received a time extension have a fully executed Amendment by November 30, 2008. With regard to the Lapsing Policy, sponsors are required to obligate/allocate federal or state funds and expend local Proposition C funds within three years from July 1st of the fiscal year in which the funds are programmed. This report provides the list of projects, that are out of compliance with these adopted policies and whose funds are subject to lapse.

BACKGROUND

On an annual basis, the Board recertifies fiscal year funding for the Call for Projects. Through the annual Recertification and Deobligation process, they also receive the list of projects that are moving forward, but need more time to be completed. For projects funded with Proposition C local sales tax dollars, a MOU must be executed by December 31, 2008 deadline. For sponsors whose projects are funded with Regional Surface Transportation Program (RSTP), Regional Improvement Program (RIP), Congestion Mitigation and Air Quality (CMAQ) funds or State Transportation Improvement Program Transportation Enhancement (STIP TE) funds, a LOA must be executed by this same deadline. For projects that received a time extension, we require that an Amendment be executed by November 30, 2008.

As of March 31, 2009, there are 16 projects without an executed MOU/LOA or Amendment. Attachment A contains the list of the projects.

Also on an annual basis, we review the status of each project whose funds are subject to lapse at the end of the fiscal year. For those projects whose federal, state or local funds are not obligated, allocated, or expended, sponsors are notified that their projects may be subject to deobligation.

As of March 31, 2009, there are 72 potential projects with programmed funds that are subject to lapse on June 30, 2009. Attachment B contains the list of the projects.

NEXT STEPS

We will continue working with the project sponsors to ensure timely completion of the agreements. We will also formally notify sponsors of their upcoming lapse date and continue to work with them to ensure timely completion of their projects. For those projects that continue to be out of compliance with the adopted Timely Use of Funds Policy and Lapsing Policy, sponsors will be given an opportunity to appeal the proposed deobligation of funds to our Technical Advisory Committee (TAC) in June 2009. TAC will then make a recommendation to our staff on whether the project should be deobligated. Projects subject to deobligation will be brought to the Board in July 2009.
