SUBJECT: DISPOSAL OF 51 SURPLUS/OBSOLETE BUSES

ISSUE

Federal Transit Administration (FTA) guidelines allow for retirement of buses with over 500,000 miles or 12 years of service. With the introduction of new buses into the fleet, the MTA has continued to retire buses that meet this retirement criteria. Disposal of the surplus/obsolete buses will result in increased revenue to the MTA and is consistent with established MTA policy regarding asset disposal.

BACKGROUND

While MTA policy allows for the disposal of surplus buses by bid or auction, most recent sales have been accomplished by public auction. The use of public auction has been preferred, as auctions have historically generated a greater monetary return. Recently, staff has identified select buses that are in the best overall operating condition to sell through the bid process to determine if auctions remain the best disposal alternative for these buses considering the additional time and administrative cost to process an Invitation For Bid (IFB).

With the introduction of new buses into the fleet in accordance with the Accelerated Bus Procurement Plan, the MTA has retired several hundred buses in recent years that meet the FTA retirement criteria. The large number of buses being sold by the MTA and other transit properties in conjunction with diminished demand in recent years has resulted in reduced revenue from the sale of these buses.

DISCUSSION

The sale of 51 buses generated \$8,245.00 of revenue. This action conforms with the MTA's goal to maximize revenue from the disposal of its assets.


