## THREE TRANSIT CORRIDOR STATUS

### Environmental Analysis

- **Eastside** - Draft EIS/EIR has been released for a 45 day public comment period
- **Mid Cities/Westside and San Fernando Valley East-West Corridor Draft EIS/EIR** are currently being reviewed. We will continue to work with FTA to expedite their review.

### Preliminary Engineering
