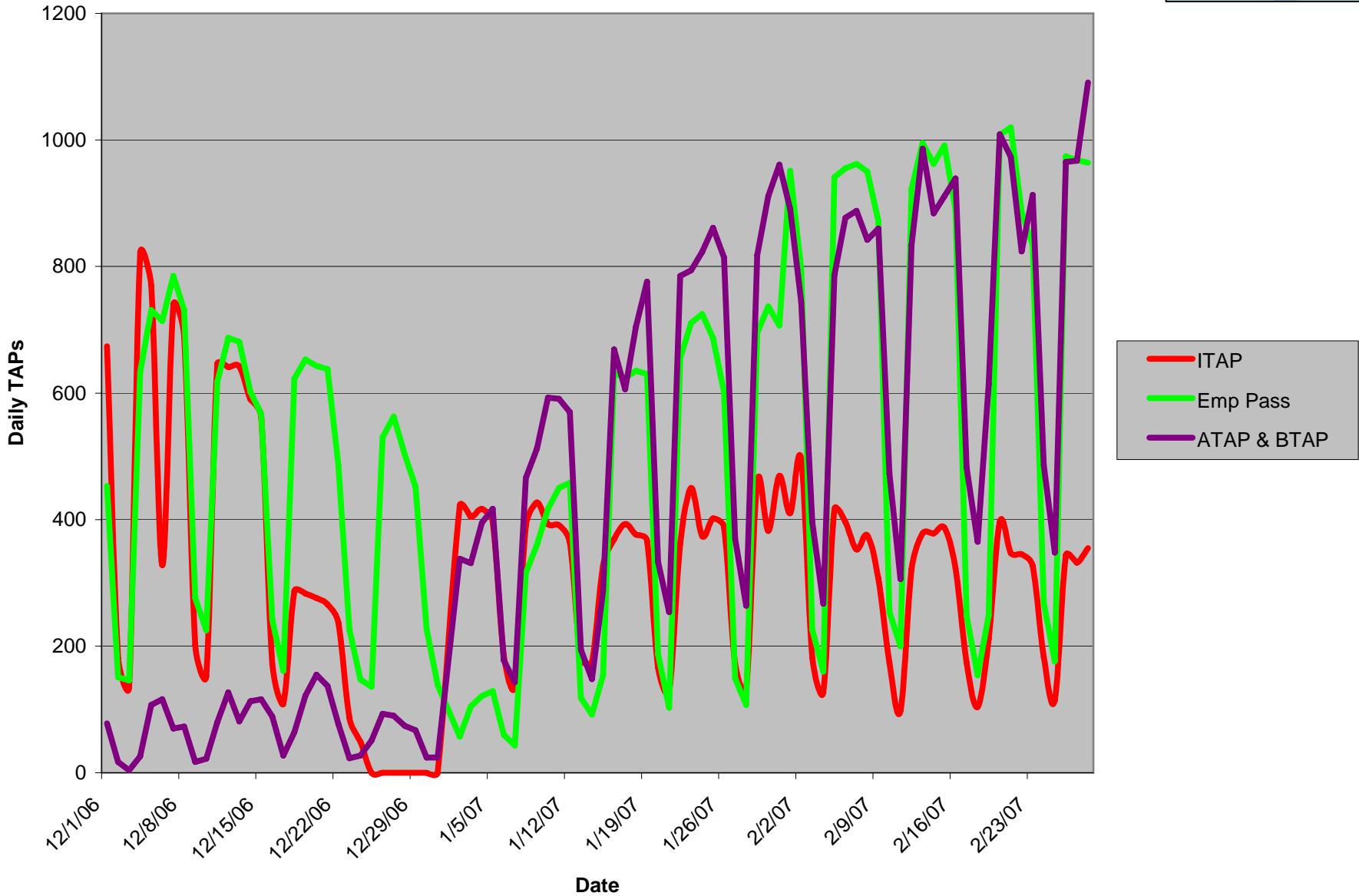

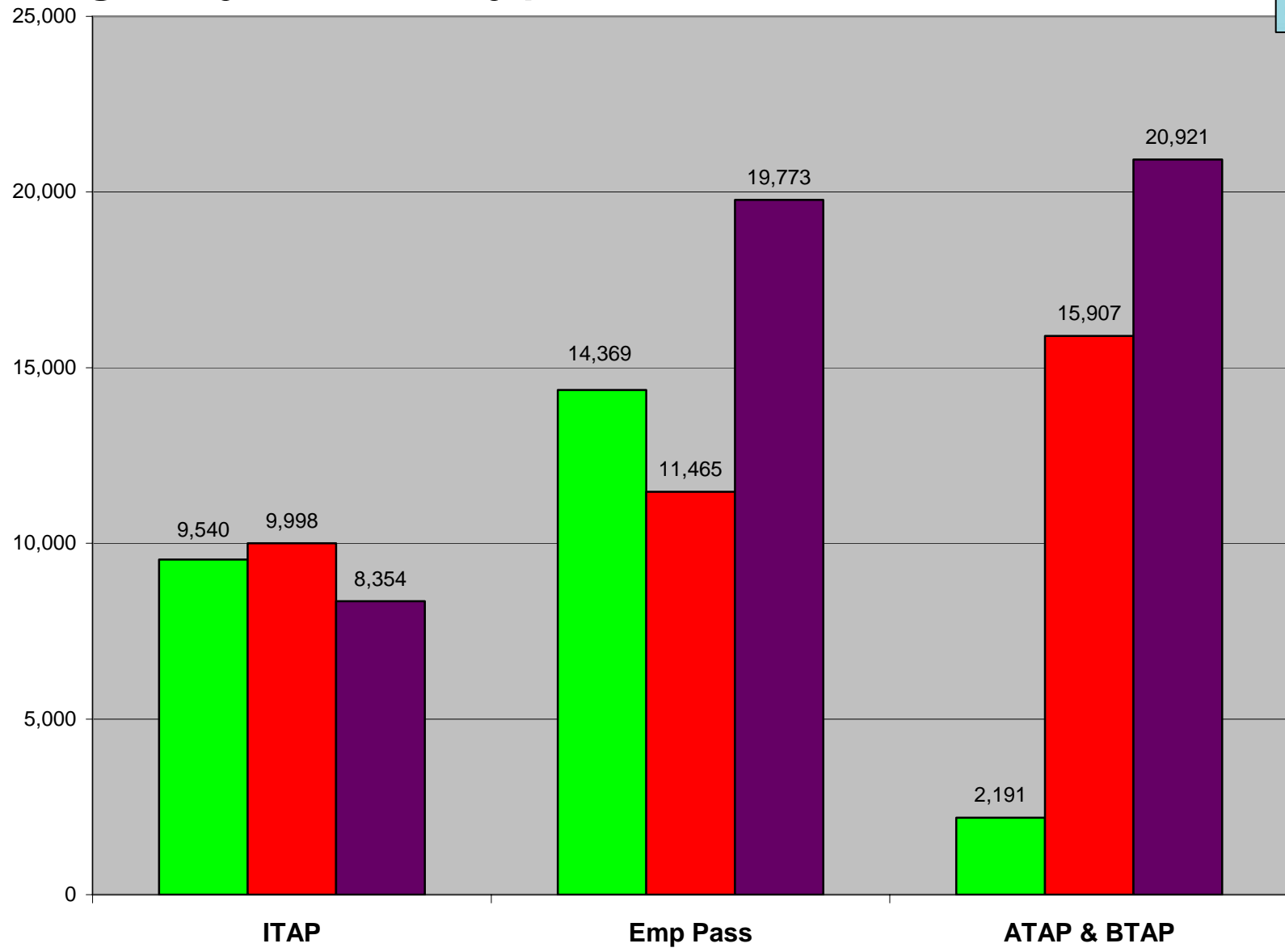
- Cubic has begun the early stages and preparation of Contracted Services Fleet

Daily TAP Usage – February 2007



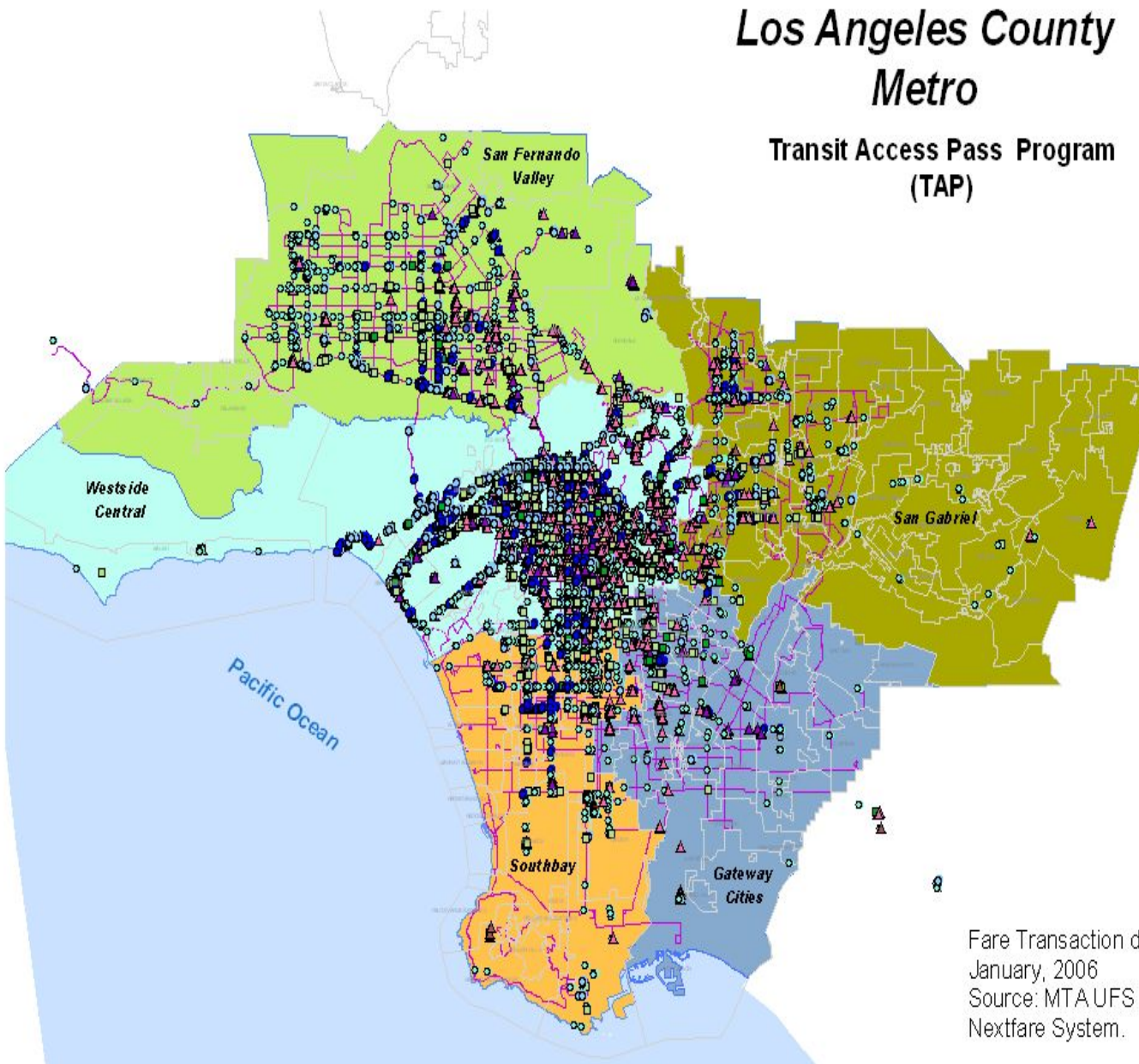
Usage by Pass Types: Dec 06 – Feb 07

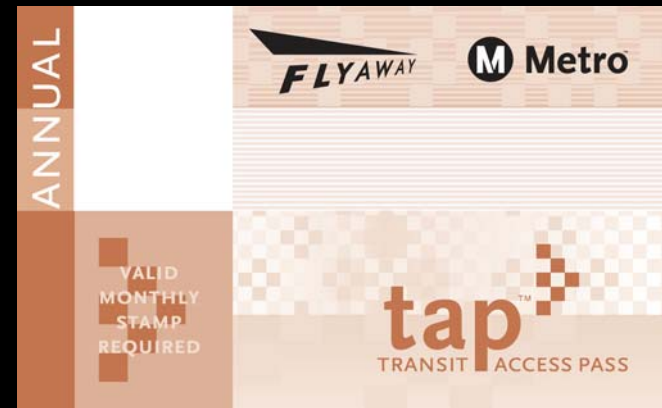


Status of Director Fasana's Motion
