

  - A. award a ten-year fixed price and indefinite quantity Contract No. 06SAFE035 to IBI Group for the **development, deployment and operation of the Motorist Aid and Traveler Information System (MATIS)** for an amount not to exceed \$34,000,000, inclusive of two, two-year options and a 10% contingency, effective March 1, 2008; and
  - B. amend the FY08 budget to add three full-time equivalents to support the development, deployment and management of MATIS.

AUTHORIZED the Executive Officer to award a five-year fixed labor hour rate Contract No. 07SAFE16 to Jennillian Corporation for **technical support services to aid in the development, deployment and operation of Motorist Aid and Traveler Information System** for an amount not to exceed \$975,000, inclusive of a 10% contingency, effective February 1, 2008.
