Minutes of Regular Meeting of  
the Members of the Authority

April 2, 1963

Upon notice duly given, the Members of the Los Angeles Metropolitan Transit Authority met at a regular meeting in the Authority Board Room, 1060 South Broadway, Los Angeles 15, California, at 10:30 a.m. on April 2, 1963, at which time the Chairman called the meeting to order.

Chairman A. J. Eyraud, Members Mark Boyar, Walter M. Briggs, Fred S. Dean, N. R. Dumont, Martin Pollard, and Warden Woolard were present. Also present were Executive Director C. M. Gilliss; General Attorney Gerald G. Kelly; General Manager Cone T. Bass; Treasurer Walter J. Braunschweiger; Controller H. L. Black; Director of Public Relations R. O. Christiansen; Chief Engineer Ernest R. Gerlach; Secretary Virginia L. Rees; and the public.

The Minutes of the Regular Meeting held March 19, 1963 were approved.

Mr. Eyraud presented the Authority's Certificate of Merit to Mr. Bryson G. Biehn, Operator-of-the-Month for April 1963, in recognition of the outstanding courtesy displayed by Mr. Biehn toward his passengers and the public.

Report of Director of Public Relations

Mr. Christiansen presented the report of the Public Relations Department, a copy of which is on file with the Secretary.

Agreement with Luria Bros. (Removal of overhead)

After discussion, upon motion duly made, seconded and unanimously carried, the following resolutions were adopted:

WHEREAS, on March 7, 1963 the Purchasing Agent called for bids on the removal and sale of trolley overhead facilities, utility poles, automotive line equipment and line tools; and

WHEREAS, the Purchasing Agent received bids from four dealers; and

WHEREAS, it is the desire of the Authority to sell such equipment to the highest responsible bidder; and

WHEREAS, the Purchasing Agent has certified the bid of Lipsett Division of Luria Bros. & Company, Inc. as the highest responsible bid;

NOW, THEREFORE, BE IT RESOLVED, that the bid of Lipsett Division of Luria Bros. & Company, Inc., in the amount of \$313,309.00, including sales tax, be and the same is hereby accepted;

RESOLVED FURTHER, that the Executive Director be and he is hereby authorized to execute on behalf of the Authority a contract between the Authority and Lipsett Division of Luria Bros. & Company, Inc., as discussed at this meeting, relating to the removal of trolley overhead facilities, utility poles, automotive line equipment and line tools, said agreement to be subject to approval as to form by the General Attorney.

Approval of Revised Work Order No. 1579

After discussion, upon motion duly made, seconded and unanimously carried, the following resolution was adopted:

WHEREAS, on November 6, 1962, the Authority approved Work Order No. 1579 at the estimated cost of \$15,050 covering certain grading, paving, and wiring in Mechanical Building, Division 3305; and

WHEREAS, actual costs have exceeded the anticipated costs;

NOW, THEREFORE, BE IT RESOLVED, that Revised Work Order No. 1579, covering grading and paving with asphalt concrete of Bays 2, 3 and 4 in Mechanical Building, Division 3305, and installation of wiring for illumination adequate for parking and security of coaches in the above numbered Bays, at an estimated cost of \$15,665.00 be and the same is hereby approved.

Comprehensive Dishonesty, Disappearance and Destruction Bond - Marsh McLennan-Cosgrove & Co.

After discussion, upon motion duly made and seconded, the following resolutions were voted upon:

WHEREAS, on February 5, 1963, the Authority authorized the Executive Director to advertise for bids to provide a Comprehensive Dishonesty, Disappearance and Destruction Bond; and

WHEREAS, invitations to bid were mailed to 12 brokers and/or insurance companies and an invitation to bid was published in the Los Angeles Daily Journal; and

WHEREAS, 7 responses were received to the invitations to bid; and

WHEREAS, 3 identical low bids were received from three brokerage firms: Marsh McLennan-Cosgrove & Company, Olympic Insurance Agency, and The Rule Company, which brokerage firms were
