2 } 4 ✓ On May 15, 1962 the Authority approved the purchase by the State of California of a non-exclusive easement in favor of the Pacific Electric Railway Company along the northeasterly line of the Authority's Macy Street coach yard for a consideration of \$14,000.

However, since the location of the easement was not acceptable to the Pacific Electric, further negotiations were entered into and all parties are now willing to enter into a non-exclusive easement agreement across a portion of MTA's Macy Street property, which easement agreement has already been approved as to form by the General Attorney, for a consideration of \$19,135.86.

It is recommended that the Executive Director be authorized to execute the above described easement agreement on behalf of the Authority, and that the May 15, 1962 resolution be rescinded.
