Minutes of Special Meeting of  
the Board of Directors of the District

February 14, 1967

Upon notice duly given, the Directors of the Southern California Rapid Transit District met at a special meeting in the District Board Room, 1060 South Broadway, Los Angeles, California, at 9:30 a.m. on February 14, 1967, at which time President Harry A. Faull called the meeting to order.

Plan for Redemption of Outstanding Revenue Bonds of District  
Proposed by Southern California Rapid Transit Develop-  
ment Foundation, Inc.

President Faull submitted to the meeting for consideration the resolution adopted January 17, 1967 by the Officers and Directors of the Southern California Rapid Transit Development Foundation, Inc. proposing a plan for redemption of the outstanding Revenue Bonds of the District and other matters relating to the District. A copy of the resolution, together with a copy of the transmittal letter dated January 20, 1967, is filed with the Secretary.

After a thorough discussion, it was moved by Director Hayward, seconded and unanimously carried

That the resolution adopted January 17, 1967 by the Southern California Rapid Transit Development Foundation, Inc. proposing a plan for redemption of the outstanding Revenue Bonds of the District and other matters relating to the District, in view of its complexities, be referred to the Rapid Transit Planning and Finance Committee for study and report back to the Board.

Director Allen requested that the Staff extend to the Southern California Rapid Transit Development Foundation, Inc. the District's appreciation for the interest and independent efforts expended by it in the development of rapid transit improvements in the Southern California area.
