# Project Labor Agreement (PLA)

## **What is a Project Labor Agreement (PLA)?**

- A type of contract with the trades used in the construction industry to set the terms and conditions of employment.

## **What is the purpose of a PLA?**

- Provides ample skilled workers for a project
- No work stoppages
- Expedited resolution of disputes
- Timely completion of the project



# Construction Careers Policy (CCP)

## What is a CCP?

- Designed to provide employment and training opportunities to targeted workers via a PLA

## Are there goals associated with the CCP?

- Yes. Federal vs. Non-Federal
- 40% Targeted Workers
- 10% Disadvantaged Workers
- 20% Apprentice Workers
  - Half of Apprentice Workers = Targeted Workers

The PLA and CCP were approved by Metro's Board of Directors on January 26, 2012 and negotiated with the Los Angeles/Orange County Building Construction Trades Council (LAOCBCTC) to help facilitate the timely completion of transit projects in LA County.

## PLA Hiring Requirements
