Line Ride Program

Background

- Gateway Cities Service Council receives staff report at April 14, 2016 meeting recommending adoption of the Bus Line Ride program.

 - Provide members with list of Metro Bus lines that operate in or near communities where they work or live;

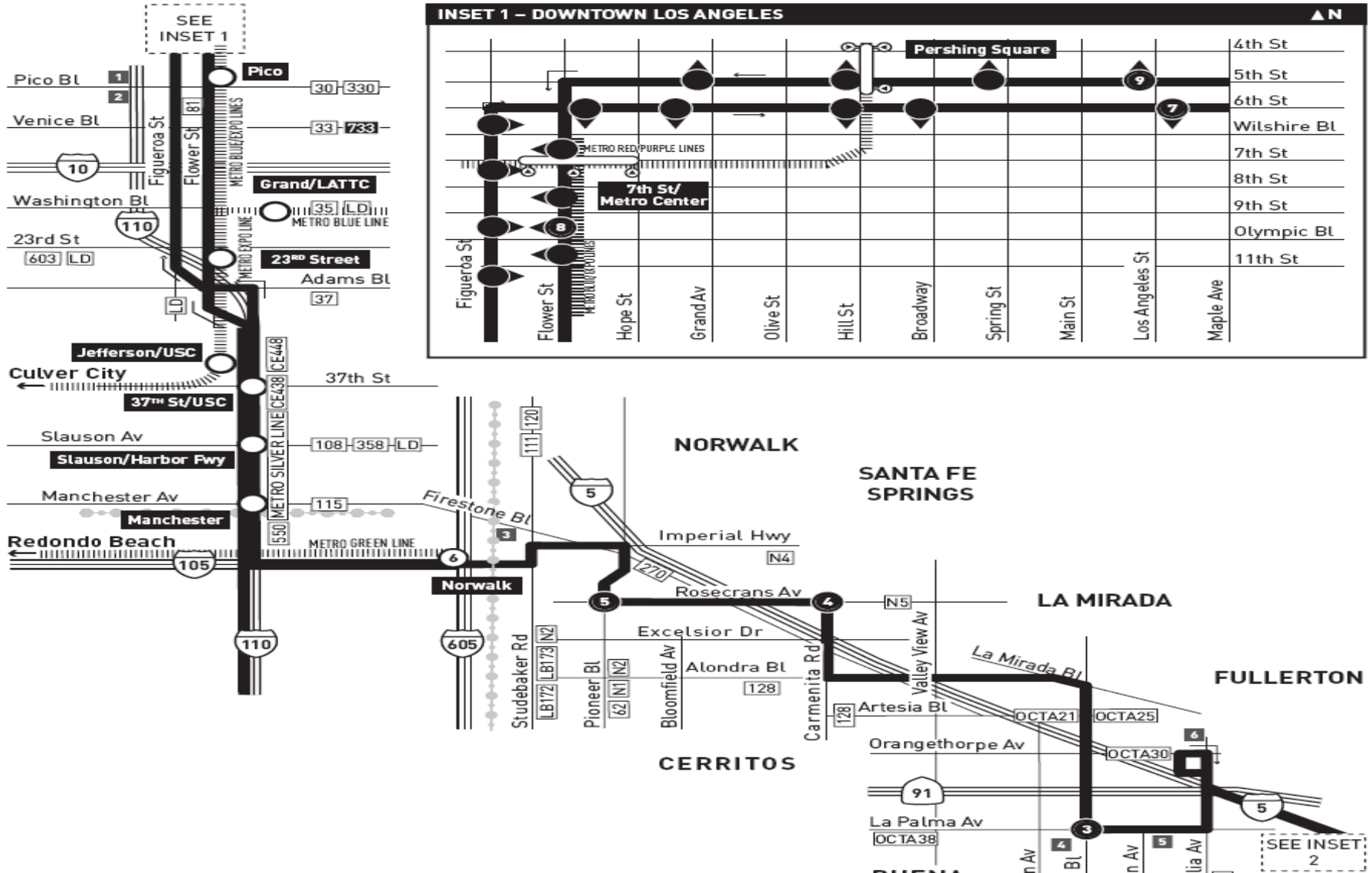
