Re: Studio City Neighborhood Council Motion

Dear Commissioners:

The Studio City community has long sought recognition for its real boundaries. Last year the City of Los Angeles posted community signs surrounding the Studio City community, including the signage atop the Metro Red Line Station currently named "Universal City Station."

We are aware that there have been several station name changes, so our request has precedent. The following stations have been renamed:

- Alvarado changed to WESTLAKE/MACARTHUR PARK
- 7th Street/Metro Center changed to 7th ST./METRO CENTER/JULIAN DIXON
- Vermont/Santa Monica changed to VERMONT/SANTA MONICA/L.A. CITY COLLEGE
- 103rd St./Watts changed to 103rd ST./KENNETH HAHN

and others.

Since the entire property of the "Universal City Station" is within Studio City, we believe the station should include Studio City in its name. With this in mind, the Studio City Neighborhood Council passed the accompanying motion.
