Service Council Members discussed accessibility and costs of the various potential public hearing sites and thanked staff for researching various options on short notice.

JK Drummond insisted that staff should have contacted the Los Angeles Mayor's office and Councilmember Joe Buscaino to assist with finding a hearing location within San Pedro. He added that staff should have tried harder to find a location in San Pedro for the public hearing and that staff should have contacted the Croatian Cultural Center, Anderson Memorial Center, and the County Services Center to see if they were available.

3. PUBLIC Comment

JK Drummond commented that the Line 450 and 550 timetable connection information is contradictory with regards to the Carson North/South Shuttle.
