**SUBJECT: DECEMBER 2007 SERVICE CHANGE PROGRAM PUBLIC HEARING**

**ACTION: SET PUBLIC HEARING DATE FOR PROPOSED DECEMBER 2007  
SERVICE CHANGES AND AUTHORIZE PUBLICATION OF THE  
NOTICE OF PUBLIC HEARING**

**RECOMMENDATION**

- A. Schedule Wednesday, August 8, 2007 at 5:00pm as the hearing date and time to receive public comment on the proposed service changes to be implemented in December 2007.
- B. Authorize publication of the Notice of Public Hearing (Attachment A).

**BACKGROUND**

A Notice of Public Hearing is scheduled for publication on Sunday, July 1, 2007. Service changes will be considered on the following lines and routes.

- Line 38-71 (WLA Transit Terminal - CSULA via Jefferson Bl - City Terrace Dr)
- Line 68-368 (WLA Transit Terminal - Montebello via Washington Blvd. - Chavez Av.)
- Line 728 (Downtown LA - Century City via W. Olympic Blvd.)

In compliance with federal public hearing requirements and adopted MTA policy, the Governance Council is required to conduct a public hearing and consider public testimony before approving significant modifications to the bus system. As part of this process, the Governance Council is also required to consider potential impacts these changes may have on the community.

The changes are proposed to improve the efficiency of bus operations within the sector, and to ensure a balanced budget for next fiscal year. In an effort to move forward with projects that will improve service quality and increase operating efficiencies, staff proposes to initiate the service changes contained in the public hearing program as early as December 16, 2007. The proposed Westside/Central changes are consistent with the Los Angeles Transportation Authority's (LACMTA) Metro Connections Program. The changes proposed are part of a broader service improvement program designed to improve travel times, simplify routes, and reduce service duplication.

The Notice of Public Hearing (Attachment A) gives the time, date, and location of the public hearing and a brief summary of the changes under consideration.

### **SUMMARY OF STAFF PROPOSALS**

The proposed Westside/Central service plan includes modifications to four routes and implementation of one new Rapid service. Following is a brief description of the individual proposals.

Line 38-71 (WLA Transit Terminal - CSULA via Jefferson Bl. - City Terrace): Restructure Line 38 to operate from Downtown LA (Grand Station) to WLA Transit Terminal. Incorporate Line 71 service into Line 70. San Gabriel Valley Sector will be responsible for scheduling and planning Line 71.

Line 68-368 (WLA Transit Terminal - Montebello via Washington Blvd. - Chavez Av.): Restructure route due to implementation of new Cesar-Garvey Rapid 770. Line 770 will operate from Downtown LA to El Monte Station via Cesar Chavez Av and Garvey Av. Cancel Line 368. Proposed new line 35-335 operating from Downtown LA (Broadway/Washington) to WLA Transit Terminal. Discontinue service from Broadway/Washington to Broadway/1<sup>st</sup>. Retain Line 68 service from Broadway/1<sup>st</sup> to Montebello Town Center. Line 68 segment would be tied into Line 84 and San Gabriel Valley Sector would be responsible for this service.

Line 728 (Downtown LA - Century City via W. Olympic Blvd.) Implement new Rapid service on W. Olympic Bl. At present, San Gabriel Valley is responsible for Line 28-328-83-84. Westside/Central will plan and schedule Line 28 and new Rapid Line 728.

### **NEXT STEPS**

Following the public hearing, staff will return to the Governance Council with a report summarizing all public comments received along with specific staff recommendations.

**NOTICE OF PUBLIC HEARING  
Los Angeles County Metropolitan Transportation Authority**

The Los Angeles County Metropolitan Transportation Authority will hold three public hearings in August 2007 to receive community input on proposed modifications to Metro's bus services. Approved changes will become effective December 16, 2007 or later. Details of the hearing dates, times, and locations are listed at the end of this notice.

The upcoming public hearings are being held in conformance with federal public hearing requirements outlined in Section 5307 (d) 1 of Title 49 U.S.C., and public hearing guidelines adopted by the MTA's Board of Directors in 1993, as amended.

Listed below are the service proposals to be considered at the hearings, and the respective service sectors that will host the public hearings. In general, the proposed modifications will improve the efficiency and effectiveness of the public transportation system through a better use of resources. The public can attend any of these hearings and comment on proposals of interest to them.

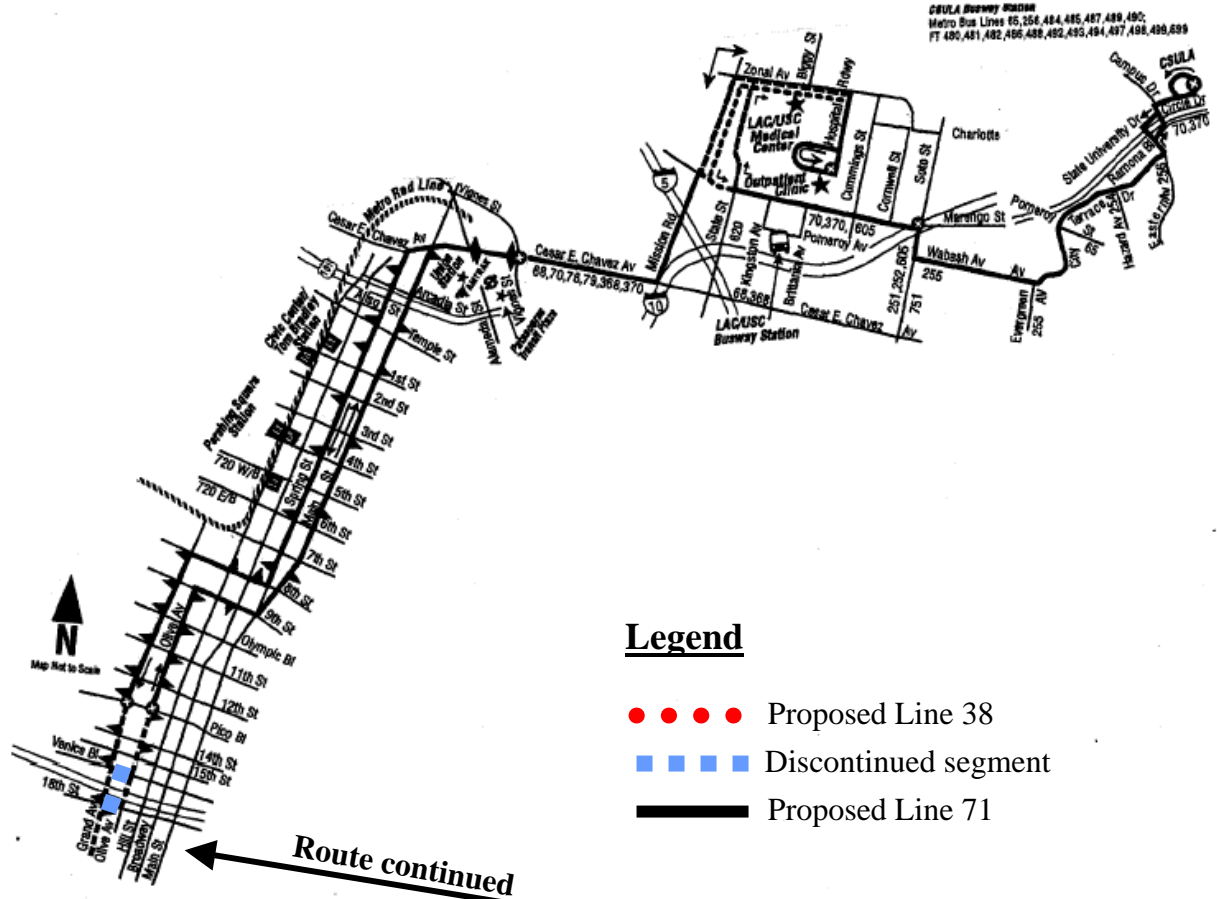

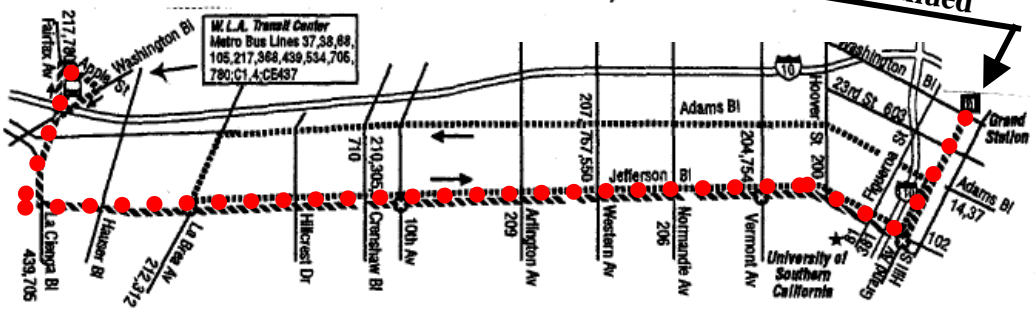
# Metro Connections Line 38-71

- Proposed Line 71



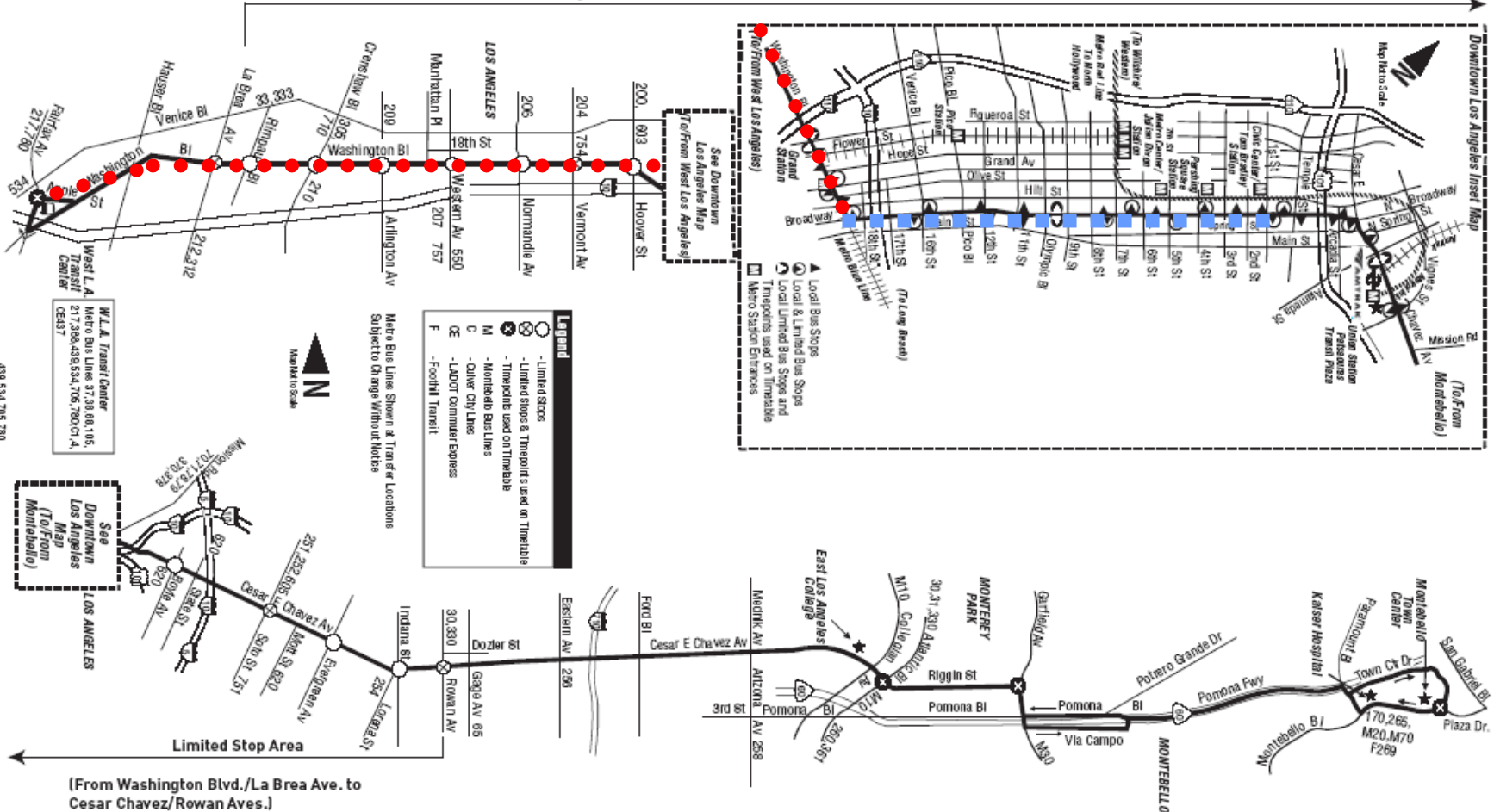

(From Washington Blvd./La Brea Ave. to Cesar Chavez/Rowan Aves.)



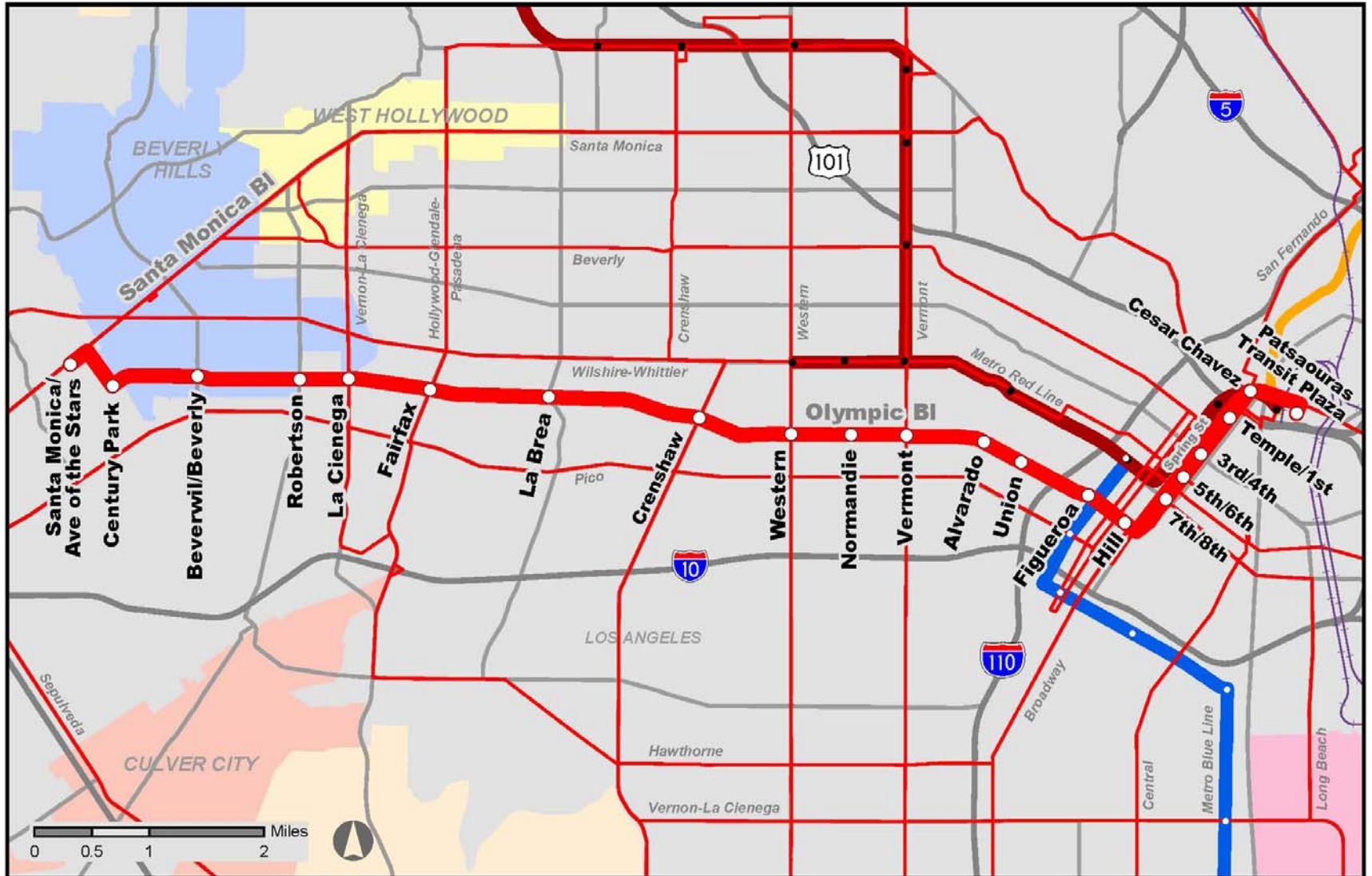
