The Westside/Central Service Sector will hold a public hearing on August, 13 2008. The purpose of the public hearing is to receive community input on proposed modifications to Metro's bus services. Approved changes will become effective December 14, 2008 or later. Details of the hearing date, time, and location are listed below.

PROPOSED SERVICE CHANGES FOR DECEMBER 2008

The Westside/Central Service Sector will hold a public hearing on Wednesday, August 13, 2008 at 5:00pm at the La Cienega Tennis Center, 325 S. La Cienega Blvd., in Beverly Hills to receive public comment on the following service change proposals:

- Line 33/333 (Downtown LA – Santa Monica Via Venice Bl): Restructure routes 33 and 333 to improve service quality

The proposed changes are illustrated on the attached map.

If approved by the Metro Governance Councils and Board of Directors, these changes will be implemented as early as December 2008 or later.

SUMMARY OF SERVICE CHANGE PROPOSAL

Line 33 local service proposed to operate from Main/6th in downtown LA to Main/Sunset in Venice. Line 333 limited stop service proposed to operate from Union station to Ocean/Santa Monica in Santa Monica.

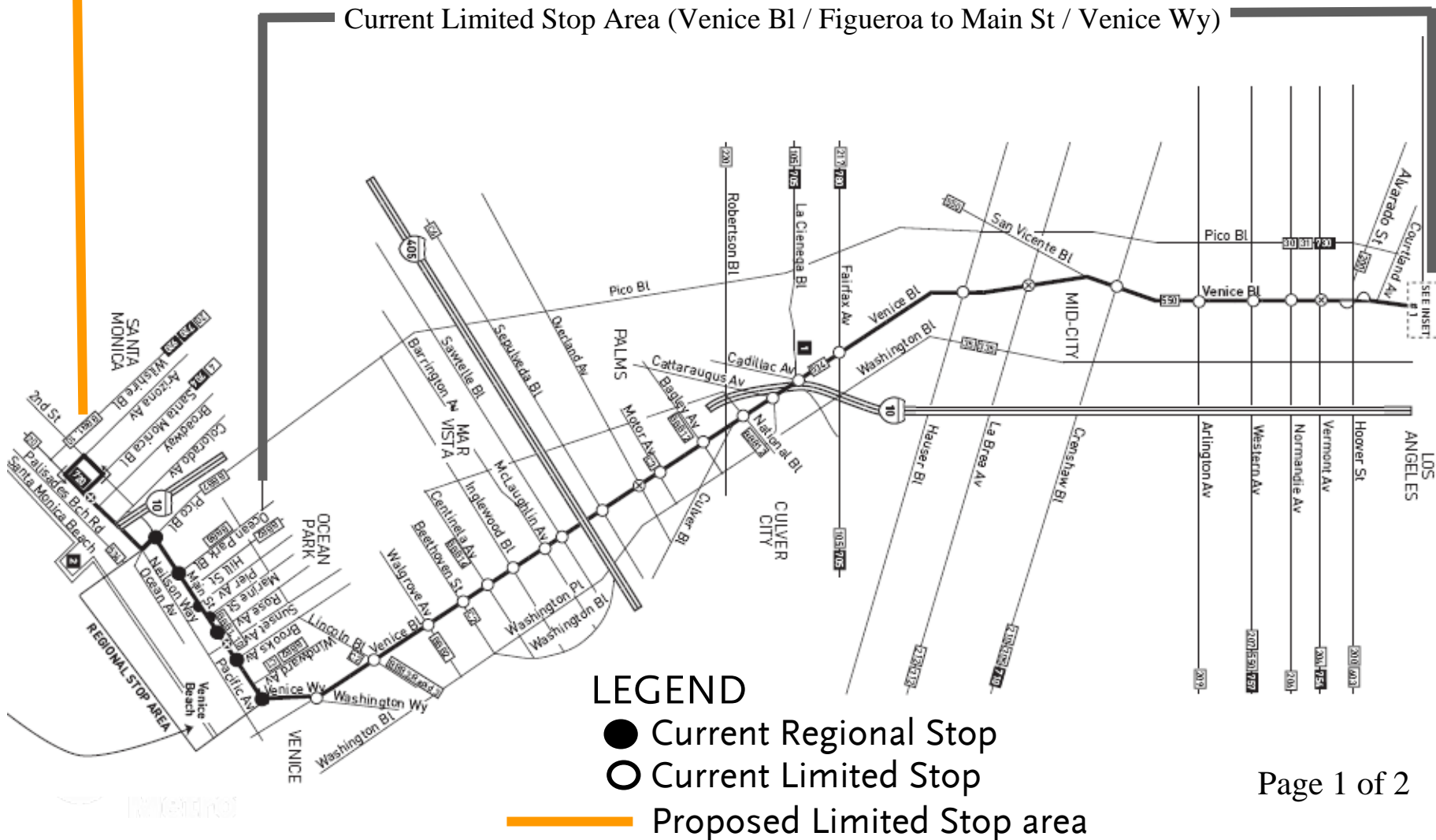

Line 33 Main/6th in Downtown LA to Main/Sunset in Venice

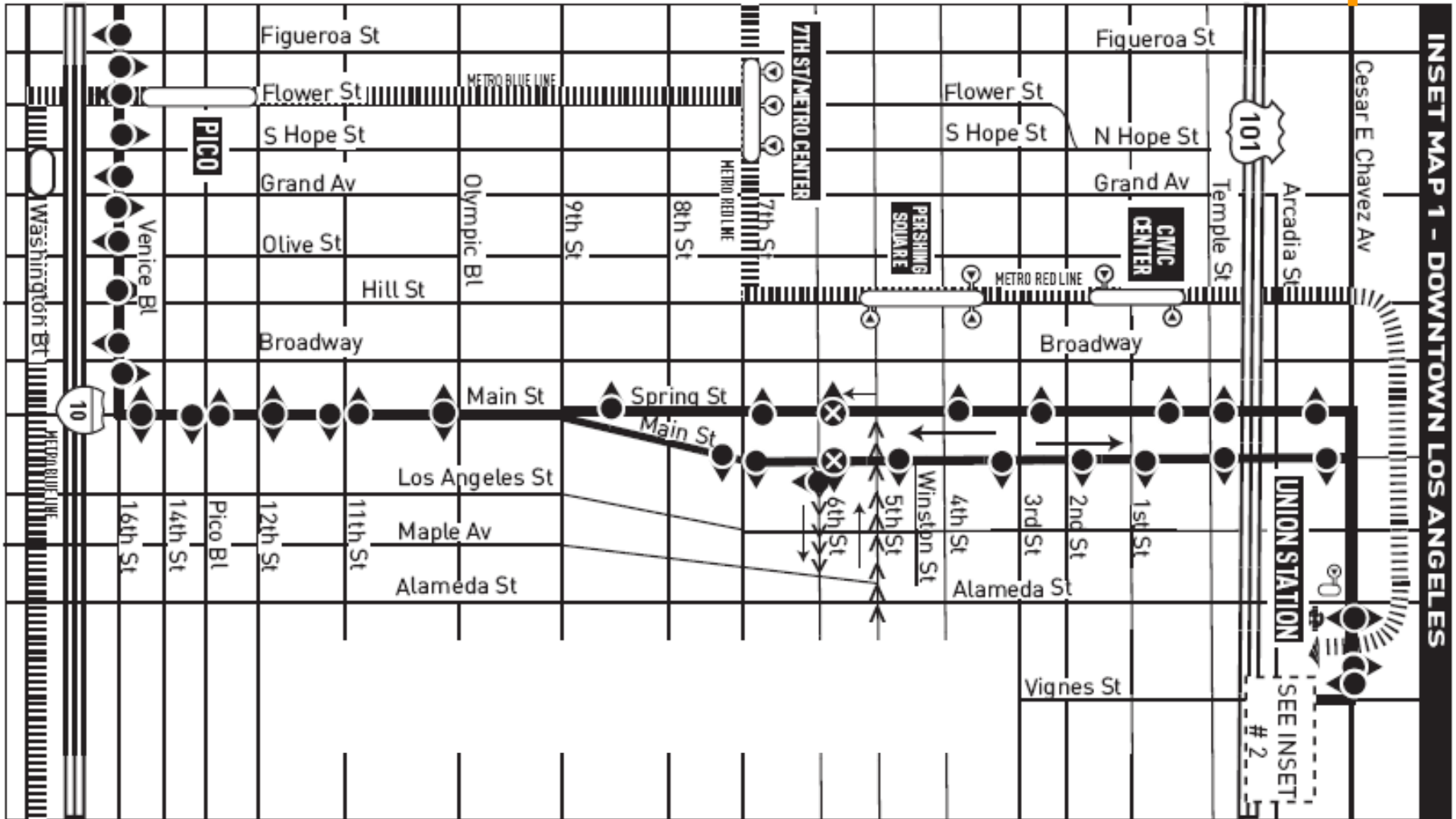
Proposed Limited Stop Area (Patsaouras Transit Plaza to Ocean/Santa Monica)
