BACKGROUND

- **December 9, 2009 – Council authorized publication of hearing notice and approved public hearing date**
- **January 3, 2010 – Public hearing notice was published**
- **February 10, 2010 – Council conducted public hearing**
- **March 10, 2010 – Staff returns with hearing findings and revised service change program**

SUMMARY OF PUBLIC COMMENTS

Twenty-two individuals provided input during public comment period – 10 oral and 12 written

- Line 30-31 – Three comment supported and two comments opposed recommendation
- Line 217 – Three comments supported and four opposed recommendation

SUMMARY OF PUBLIC COMMENTS (continued)




- Line 33-333 – Ten comments supported and two comments opposed recommendation
- Line 733 – Twelve comments supported and none opposed recommendation
- Twenty-eight of the 36 comments supported the proposals

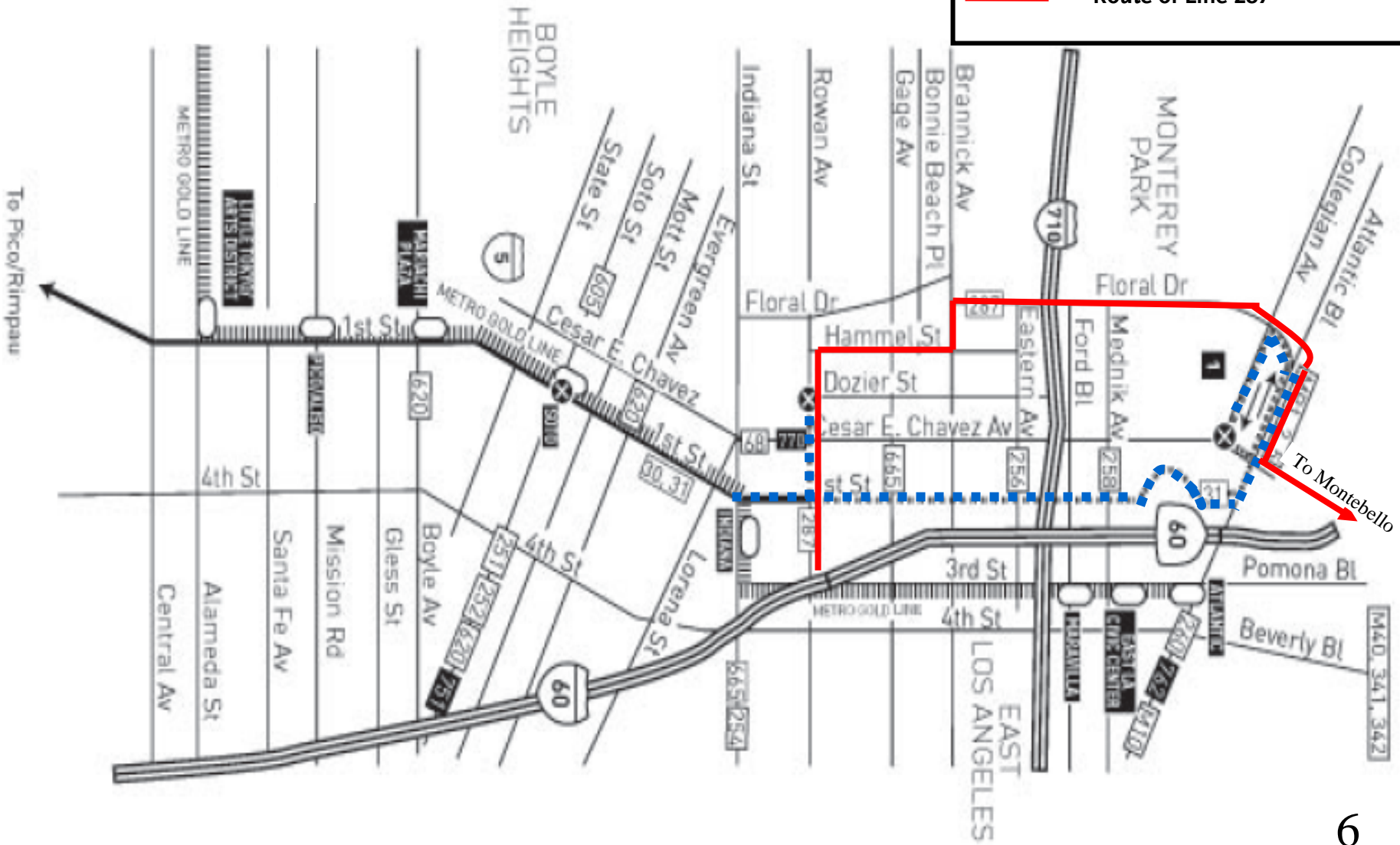
SUMMARY OF STAFF RECOMMENDATIONS

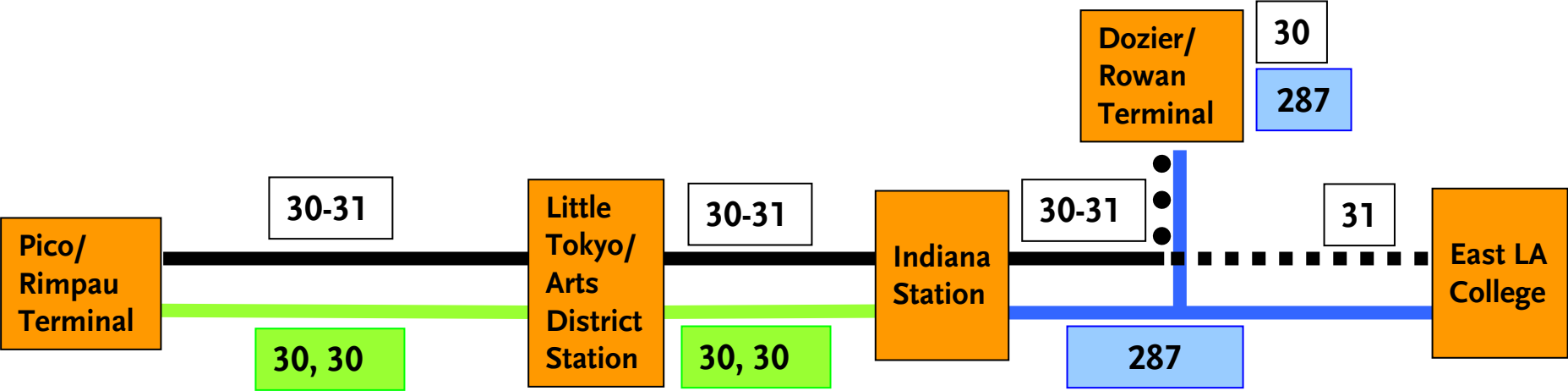

LINE 30-31 SERVICE



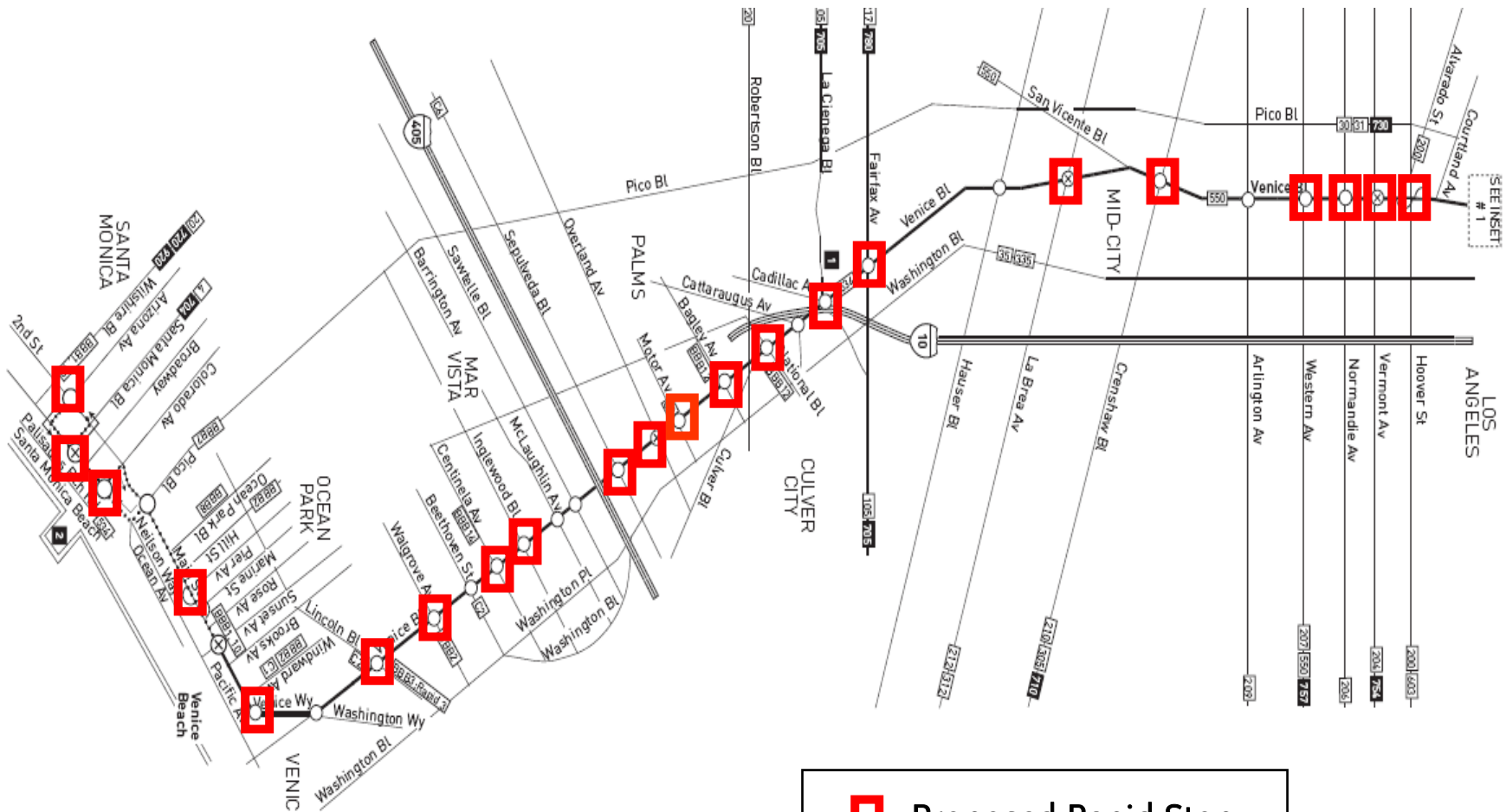
SUMMARY OF STAFF RECOMMENDATIONS (continued)

- **Line 33-333 & Line 733 – Replace service on Line 333 with new Rapid Line 733**

Revised proposal:

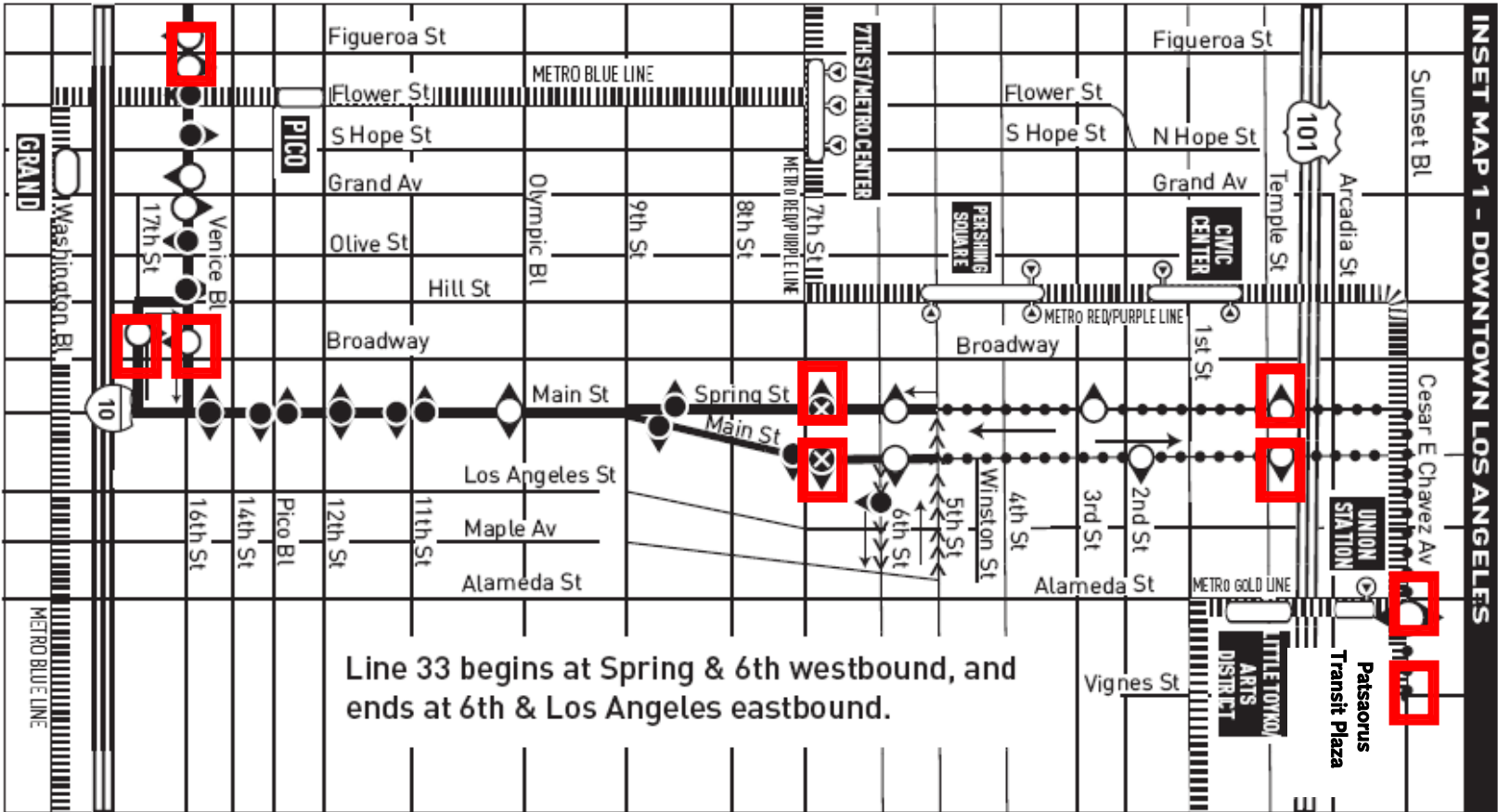
- **Line 733 will operate from approximately 5am to 11pm**
- **Line 33 will operate same pattern as today during Line 733 operation, and**
- **Between 11pm to 5am Line 33 will operate in local mode from Patsaouras Transit Plaza to Santa Monica**
- **Added stop at Motor Avenue**

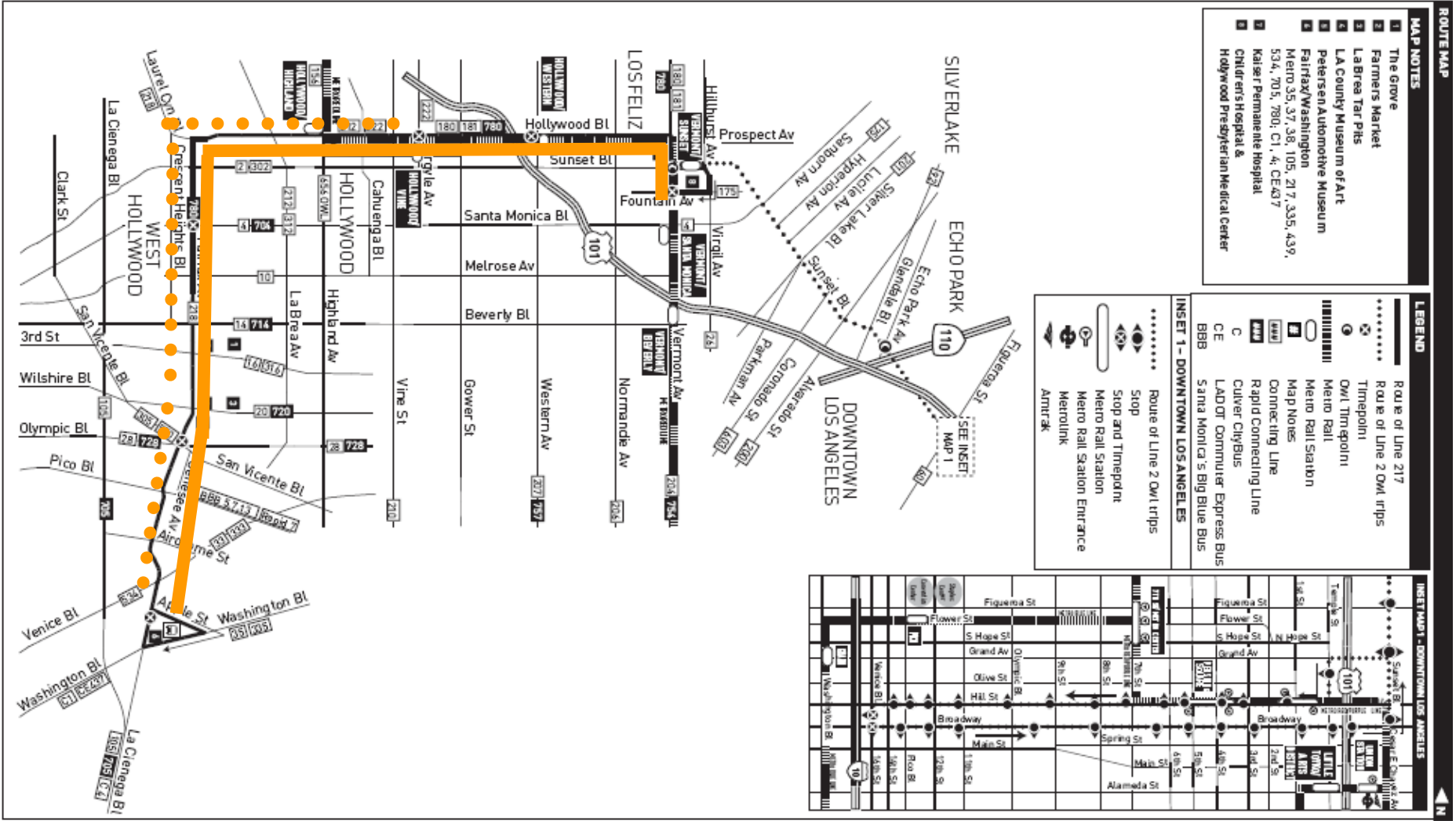
SUMMARY OF STAFF RECOMMENDATIONS (continued)

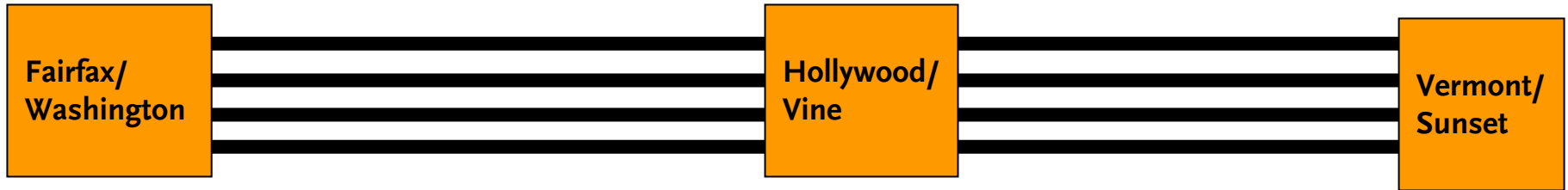
- **Short-line will be implemented on weekdays and Sunday from approximately 7am – 8pm.**

LINE 217 – CONSIDER IMPLEMENTATION OF SHORT LINE TRIPS AT HOLLYWOOD/VINE STATION

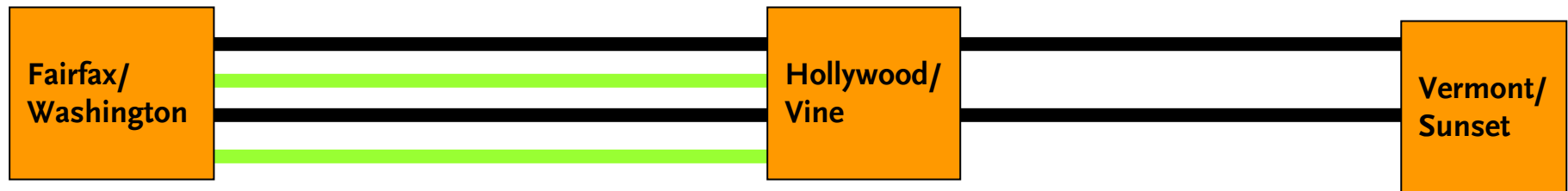
