**SUBJECT:** INVESTMENT TRANSACTIONS FOR THE MONTH ENDED  
FEBRUARY 29, 2020

**ISSUE**

The attached investment transactions reports are provided in accordance with our Investment Policy approved on February 28, 2019, and the California Government Code.

**BACKGROUND**

Metro's investment policy allows for temporary idle funds to be invested consistent with Board approved investment policy guidelines. This monthly investment transactions report meets the reporting requirement of the Investment Policy.

**DISCUSSION**

During the month, investment purchases totaled \$749.4 million and investment sales totaled \$23.4 million, including interest. In addition, \$3.9 million in call options were exercised in the portfolio during the month of February. Following is a summary of transactions made by the respective Portfolio Managers.

Our short and intermediate investment portfolios, valued at market plus accrued income, totaled \$1.53 billion as of the end of February versus \$1.39 billion as of the end of January. The increase was due to monthly revenues in excess of expenditures. After accounting for withdrawals, the month end yield of the Operating Portfolio was 1.13% versus the combined benchmark of 1.14%.
